Cookie Policy for SFI Testnet

1. Introduction

- 1.1. This Cookie Policy explains in detail how [SingularityFinance] ("Company," "we," or "us") utilises cookies and related technologies on the SFI Testnet platform ("Testnet"). The use of cookies is fundamental to ensuring the smooth operation of the Testnet, optimising its performance, and delivering an enhanced, personalised experience for its participants.
- 1.2. By accessing or using the Testnet, you signify your acceptance of the practices described in this Cookie Policy. You retain the right to manage your cookie preferences at any time, either through the cookie management tool provided on the platform or via your browser settings.
- 1.3. Cookies play a vital role in facilitating seamless interactions and ensuring secure transactions within the Testnet ecosystem. This document aims to provide transparency regarding the types of cookies used, their purposes, and how you can control them.

2. What Are Cookies?

2.1. Cookies are small text files that are automatically stored on your device (e.g., computer, smartphone, or tablet) when you access a website. These files enable the website to recognise your device and store specific information related to your preferences, past interactions, and browsing behaviour, thereby enhancing your overall experience.

2.1.1. Types of Cookies We Use:

2.1.1.1. <u>Essential Cookies:</u> These cookies are indispensable for the operation of the Testnet and enable critical functionalities, including wallet integration, account authentication, and safeguarding user data.

- 2.1.1.2. <u>Performance Cookies:</u> These cookies gather anonymised information on how participants engage with the Testnet. Insights from these cookies help us measure and improve platform performance, ensuring optimal functionality.
- 2.1.1.3. <u>Functional Cookies:</u> These cookies store user-specific preferences, such as language selections and customisation of user interfaces, enabling a more tailored and intuitive experience.
- 2.1.1.4. <u>Analytics Cookies:</u> These cookies collect data to understand user behaviours, such as navigation patterns and engagement with platform features. This information guides the enhancement of existing functionalities and the development of new features.
- 2.1.1.5. <u>Third-Party Cookies:</u> These cookies are set by external services integrated into the Testnet, such as analytics tools, social media platforms, and reward management systems. They support additional functionalities and reporting requirements.

3. How We Use Cookies

- 3.1. The Company employs cookies to achieve specific objectives that are aligned with the efficient and secure operation of the Testnet. The purposes of cookie usage are elaborated below:
 - 3.1.1. Enhancing Platform Functionality: Cookies ensure the seamless functioning of essential Testnet features, such as wallet connectivity, token faucets, and leaderboard tracking. They enable smooth navigation across the platform, ensuring users can fully engage with its gamified elements, including point accumulation and streak bonuses.
 - 3.1.2. <u>Monitoring and Improving Performance:</u> Performance cookies allow the Company to track key metrics such as transaction throughput, page load speeds, and overall system stability. By analysing these metrics, we identify areas for improvement and implement measures to enhance reliability and responsiveness.
 - 3.1.3. <u>Providing Personalisation:</u> Functional cookies capture user preferences and behavioural patterns, facilitating a customised experience. For example, these

- cookies enable the platform to remember your language preferences and suggest relevant content based on your interactions.
- 3.1.4. <u>Gathering Analytics and Insights:</u> Analytics cookies are pivotal for understanding user engagement. By analysing aggregated data, the Company can refine platform design, optimise usability, and prioritise features that resonate most with participants.
- 3.1.5. <u>Ensuring Security and Fraud Prevention:</u> Cookies are utilised to detect and mitigate fraudulent activities, unauthorised access, and other security threats. This ensures the integrity of user data and the overall safety of the Testnet environment.

4. Third-Party Cookies

- 4.1. The Testnet integrates services from carefully vetted third-party providers, which may employ cookies to collect and process data on our behalf. These providers include but are not limited to:
 - 4.1.1. <u>Analytics Tools:</u> Services such as [e.g., Google Analytics] that provide detailed reports on the Testnet usage and participant engagement.
 - 4.1.2. <u>Reward Management Systems:</u> Third-party platforms facilitating the distribution of incentives and rewards, which may use cookies to track eligibility and fulfillment.
 - 4.1.3. <u>Social Media Platforms:</u> Integration with social media services enables users to share content or log in using their existing social accounts.

6. Retention of Cookie Data

- 6.1. The duration for which cookies remain on your device depends on their purpose:
 - 6.1.1. <u>Session Cookies:</u> These cookies are temporary and expire when you close your browser, ensuring they do not persist beyond your session.
 - 6.1.2. <u>Persistent Cookies:</u> These cookies remain on your device for a defined period or until you manually delete them. Their longevity is determined by their intended purpose, such as retaining user preferences or storing performance data.
- 6.2. The specific retention periods for each cookie type are outlined in Testnet's cookie settings tool, which provides comprehensive details for user review.
